

Wales Park Community Garden, 2021 Season

The Wales Park Community Garden (WPCG) is located at the corner of Lincolnville Avenue and Main Street in Belfast. There are currently eight standard garden plots, which each measure 4 ft. x 16 ft., and two table height raised-bed garden plots, each measuring 3 ft. x 8 ft. The garden plots will be available by lottery to any Belfast resident who applies and wins the opportunity to rent one. The lottery will be held on March 29, 2021. *Individuals requiring a table height raised-bed garden plot should indicate this on their application.* Assignment of plots will be based on two drawings: one for the standard plots and one for the table height raised-beds. A waiting list will be drawn from the remaining applicants.

Applications: You may pick up an application at the Belfast City Hall Clerk's Office or Parks & Recreation office, or download one from the Belfast Parks & Recreation website. Please mail your application to Nat Clifford, WPCG Steering Committee, PO Box 174, Belfast ME 04915. It must be postmarked by March 19, 2021, to be included in the drawing. If you would prefer to email your application, please send a filled-in PDF version of your application to clifford.WPCG@icloud.com by March 19, 2021.

Lottery: The lottery will be held on March 29, 2021 by pulling applicants' names from two buckets: one bucket for standard beds and one for individuals needing table height raised beds. All applicants' names will be drawn to establish a waiting list for the garden plots.

Registration: If your name is drawn, you will be advised via email, phone call, and/or text and informed of your plot number by March 31st. You will be asked to pay a non-refundable rental fee on a sliding scale of \$20 to \$40 by April 13, 2021.* Checks should be made payable to **City of Belfast - Community Garden with Wales Park Community Garden** in the memo field, and sent to Nat Clifford, WPCG, P.O. Box 174, Belfast, ME 04915. Funds are available for those individuals who may need financial assistance. Individuals on the waiting list will also be notified.

COVID-19 guidelines and restrictions at WPCG will continue to be evaluated based on adherence to CDC and State of Maine recommendations as they evolve during the coming months. We cannot promise use of the plots assigned to the lottery winning applicants until later in the Spring.

Deadline to garden in your plot: If the plot assigned to you has not been prepared and planted by June 15, 2021, it will be reassigned to another gardener from the waiting list.

The lottery for a garden plot at Wales Park will be held on March 29, 2021. If your name is drawn, you will be notified by phone or email by March 31st and given your plot assignment. You will be asked to register and pay a rental fee (on a sliding scale of \$20 to \$40) by April 13th. If an individual decides against using their assigned plot, it will be given to the first person on the waiting list. **Receiving a plot in 2021 does not automatically guarantee the gardener a plot for the following year. (The application process must be repeated each year.)**

Wales Park Community Garden (WPCG) Use Agreement

- o I will follow all COVID-related safety practices for gardening at WPCG (to be posted).
- o I will not come to the garden if I am sick or know that I have been exposed to COVID-19.
- o I understand I am responsible for my garden plot.
- o Per Maine law, I will not apply any pesticides. (A pesticide is any substance or mixture (even homemade mixtures) that is applied in an effort to mitigate or kill pests. A pest is a pathogen (disease), weed, insect, or animal you don't want to be there.)
- o I will not modify size/dimensions of my assigned plot. Plot size is approximately 4 ft. x 16 ft.
- o I understand I am responsible for preparing my plot for gardening.
- o I will use seed-free mulch to conserve water and reduce weeds.
- o I will harvest vegetables in a timely manner.
- o I will not grow illegal plants, invasive plants, or perennials.
- o I agree that if I am away for an extended period of time, I will make arrangements with someone to care for my plot.
- o I will notify WPCG if I am unable to harvest or care for my plot.
- o I will not shade neighboring plot(s).
- o I will not harvest from other plots without permission.
- o I agree that if I receive a notice that my plot is unkempt or weedy, I will address and resolve the issue within 10 days or my plot will be reassigned.
- o I will prepare my plot for winter by November 1, including removal of diseased plants to discourage the spread of plant diseases and pests.
- o I will place dead plant material in the designated areas or containers.
- o I will pick up any litter in my plot and adjacent area, and deposit it in trash receptacles.
- o I understand plots are non-transferable.
- o I understand individual fencing cannot extend beyond plot borders into pathways. Colored plastic fencing is not allowed.
- o I will water my plot according to water-wise guidelines, which will be posted at WPCG.
- o I will mark my tools clearly and not use other's tools without permission. WPCG is not responsible for any lost or missing tools.
- o I will not take community tools or garden materials out of the garden for personal use.
- o I will care for and respect community tools by cleaning and returning them to the designated community storage area. I will turn wheelbarrows upside down to prevent water from pooling.
- o I agree to volunteer eight hours during the season. Opportunities to volunteer will be communicated by the WPCG Steering Committee.
- o I will not obstruct walkways with fencing, unwound hoses, and plants, including vines.
- o I will not share the combination of the shed's lock.
- o I will keep pets outside of the garden area and leashed as per Belfast City Ordinance.
- o I will closely supervise/be responsible for guests and/or children I bring to WPCG.
- o I understand I cannot use my plot for commercial activity.
- o There is no smoking in the community garden.
